

ReadMe - TireMaster 9.1.1

This document includes information about the TireMaster 9.1.1 service update, which resolves issues found in the release of version 9.1.0 of TireMaster Corporate, TireMaster Plus, and TireMaster Point of Sale. Vehicles

Maintenance - CARFAX Interface Changes

This service update includes the following CARFAX Interface changes:

- CARFAX vehicle service history is no longer provided on a web page, the information is now
 organized into sections for service categories and service records, and it can be printed.
- The e-mail address entered on the myCARFAX sign-up screen is now added to the customer's contact information when an e-mail address has not already been defined for the customer.

PO System

Maintenance - Receiving Document Error Prevention

This service update prevents an error from occurring when an item is deleted from a receiving document. Previously, a deletion also removed the entry from the **Core** (cost) field for one of the items remaining on the order. Without that entry, the receiving could not be completed.

Security

New Feature - Permission Added

You can define whether users are allowed to change the price and cost of inventory items. A new permission called **Inventory View Only Price/Cost** affects how another permission, **Inventory View/ Edit Cost**, works. When both of these permissions are assigned to users, **Inventory View Only Price/Cost** overrides the editing functionality granted by **Inventory View/Edit Cost**. Therefore, users can see prices and costs for items, but they cannot edit that information, assign price matrixes, or recalculate factor-based prices on the Site Prices and Quantity screen.

Maintenance - Report Changes

This service update includes the following report changes:

• The content on the Pricing Wizard Report now matches the parameters selected on the Pricing Wizard screen.

- Duplicate reference numbers are now displayed on the Vendor Statement Report when the **Sort by Reference** check box is selected. Previously, when multiple transactions shared the same reference number, only one of the numbers was shown.
- Credit card information on the Daily Till Detail Report is now sorted by card name and then by card code (assigned in **Setup > Credit Cards**).

Note: This change affects only the report generated during the day-end closing process and not the one that can be printed from the Report List.

• Cash payments for purchase orders are no longer excluded from the Day End Daily Till Detail Report and the Day End Transaction Report.

This update includes the following changes for multi-store environments:

- A calculation issue with the Inventory Checkup report has been resolved.
- Deposits are now assigned unique document numbers to prevent data conflicts during replication.
- Replication errors caused by missing core cost and price matrix information no longer occur.
- An issue that allowed the replication of service checklist items without the associated vehicle information has been resolved.
